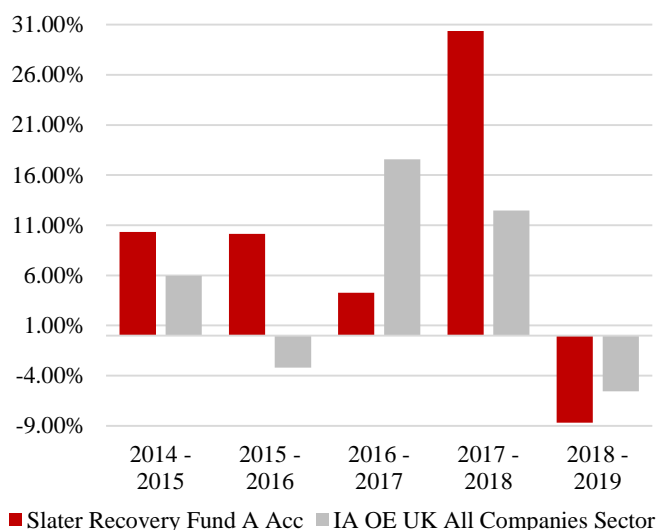




## Discrete Year Performance
