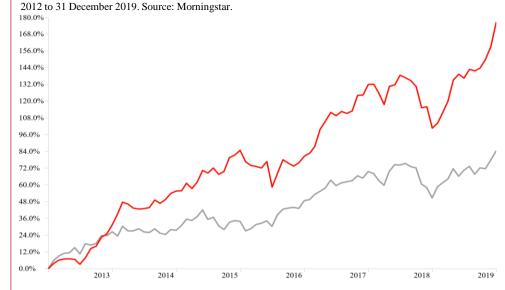

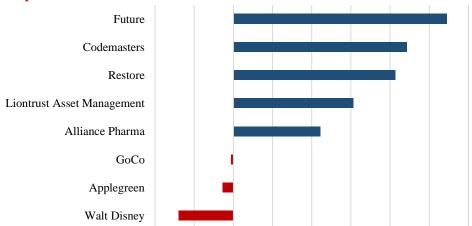

Top 5 Contributors and Detractors*



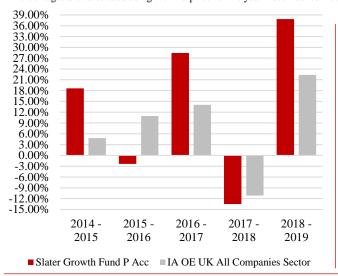
