Performance of the Fund and the IA sector on a mid price with all net income reinvested from 30 March 2005 to 30 November 2020. Source: Morningstar.



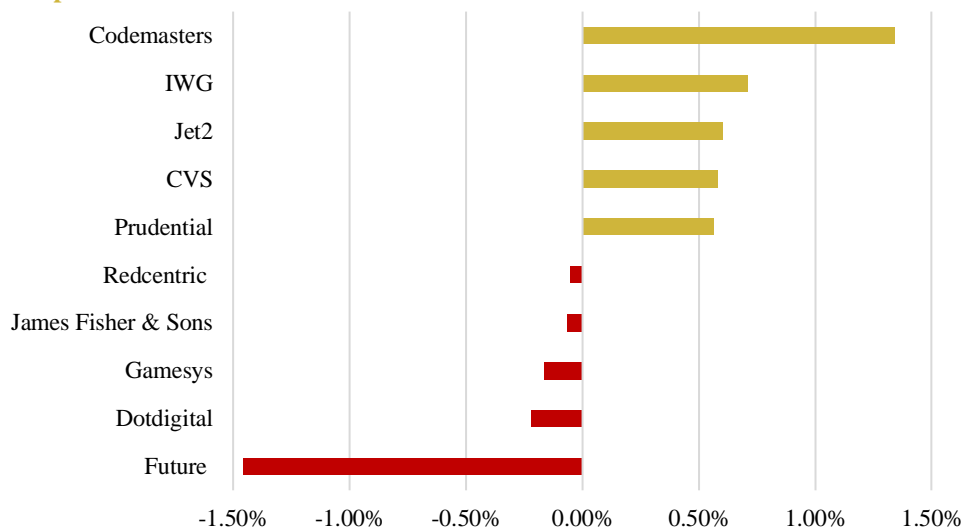
### Cumulative Performance

### Top 5 Contributors and Detractors

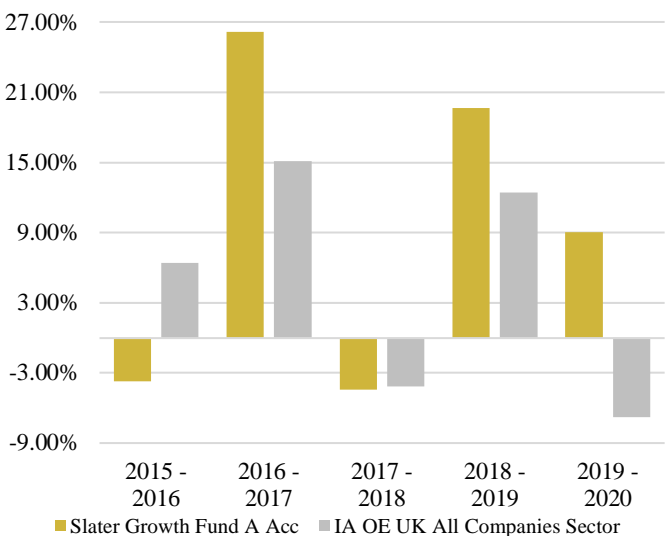
