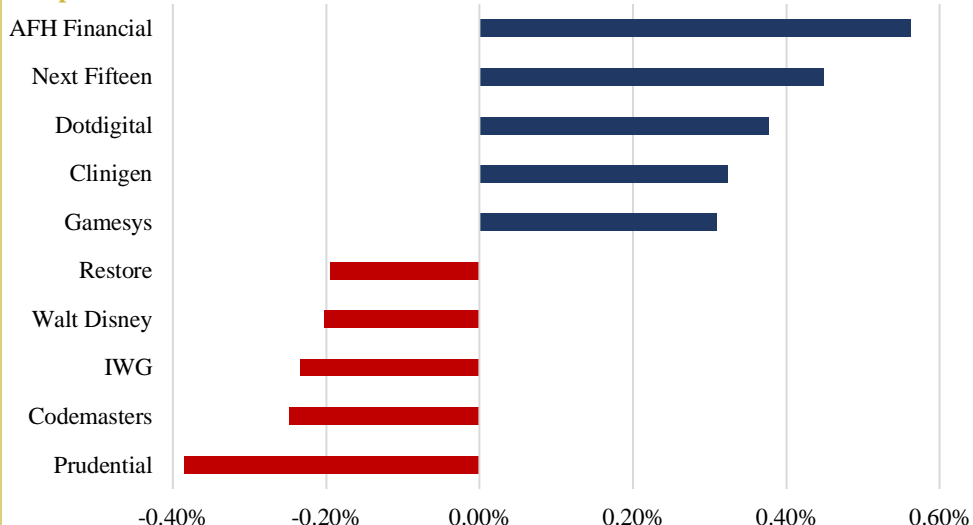
### Cumulative Performance

### Top 5 Contributors and Detractors

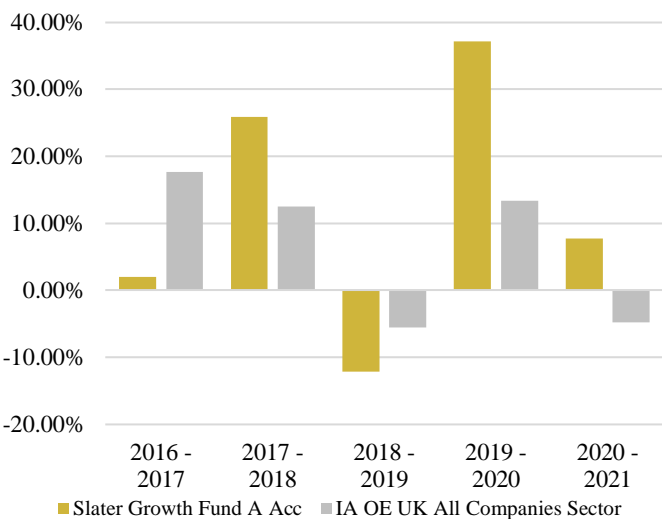
